Master of Business Administration – International Program

The National Institute of Development Administration (NIDA) is accepting applications for admission to the Master of Business Administration – International Program for the academic year 2022.

### 1. Qualification of the Applicants

- 1.1 Applicants must hold a bachelor's degree in any field or major from an accredited academic institution on before the date of application.
- 1.2 Applicants must have a TOEFL score of 500 PBT, 173 CBT and 61 iBT or IELTS score of 6.0 or NIDA TOEFL ITP score of 500 or General English Test from NIDA TEAP score of 500 or Applicants who are native speakers of English or who have completed undergraduate studies in English within 5 years prior to application.

NIDA reserves the right to examine documents and eligibility of an applicant at any time. If the applicant is found ineligible after being admitted the announcement of acceptance shall be considered null and void.

Note i: Students who pass examination(s) to enter a master degree program at NIDA must pass these English language criteria:

- 1) Students need to submit their score from one of the English proficiency tests namely NIDA TEAP or TOEFL or IELTS to apply for an interview to the program. Students must meet the minimum requirements stipulated by the program.
- 2) Students who are exempted from submitting an English proficiency test score such as students with a scholarship or students of the special program must submit their NIDA TEAP or TOEFL or IELTS score for graduation.

The periods of validity of the test score are as follows:

- 1) NIDA TEAP score is valid for 1 year until the date of submission
- 2) TOEFL and IELTS are valid for 2 years until the date of submission

Enrollment to English for graduate studies courses and the exemption from the courses are determined in compliance with the criteria and requirements stipulated in the English for graduate studies program by the Graduate School of Language and Communication, National Institute of Development Administration.

- 3) Duration, all courses take on 4 5 semesters and 1 2 summer sessions, depending on the area of study / major. All subjects / majors have to register 9 credits each semester except the summer session.
  - 4) Tuition fees may change as appropriate according to an announcement by NIDA.

Note ii: Applicants who would like to EXEMPT registration for the English language course (LC4003: Advanced Integrated English) must follow these criteria:

- 1) Applicants must hold a bachelor's and/or master's degree from an international academic institution within the past five years before classes begin; the applicant must obtain a minimum cumulative grade point average (GPA) of 2.75 from their bachelor's degree and 3.25 from their master's degree, or
- 2) Applicants who are native speakers of English are required to have a residence and permanent residence in an English-speaking country, or
- 3) Test of English as a Foreign Language (TOEFL). The minimum score is 550 for the paperand-pencil test, 213 for the computer-based test, or 79 for the internet-based test, or
- 4) Applicants who are exempted from enrolling in the English language course (LC4003: Advanced Integrated English) must request it before the first semester. If the applicants request after enrollment in the English language course, it will accept in case the grade is not shown. Thus, if the applicants receive the grade of the English language course, the exemption would not accept.

- 1) Register for getting into the online application system.
- 2) Set a password and confirm
- 3) Apply for entrance examination by choosing a school and a program of study.
- 4) Fill out profile information.
- 5) Confirm the application.
- 6) Print an invoice of application fee.
- 7) Save the application information, verify the information and confirm the application.
- 8) Upload the required documents onto the Attached Files (pdf. File) System or send the documents by e-mail to <a href="mailto:entrance@nida.ac.th">entrance@nida.ac.th</a> within December 6<sup>th</sup>, 2022 for the Fifth round.
- 9) Print a bill payment for the application and the payment must be made by December 6<sup>th</sup>, 2022 for the Fifth round at

  - 9.2) Counter Service in Thailand.
  - 9.3) Internet Banking
  - 9.4) Credit Card

- Copy of complete official transcript of undergraduate studies (Applicants holding a bachelor's degree (continuing from an Associate's degree) must submit transcripts for both degrees (Bachelor's and Associate's))
- One copy of Identification Card / One copy of Passport
- Evidence of any change of name (if applicable)
- Record of English language proficiency test (TOEFL score or NIDA TEAP or IELTS)
- In cases where the applicant has graduated from an institute outside of Thailand, students must submit:
  - (1) A Letter of Confirmation on Standard Curriculum for Bachelor's Degree
