The National Institute of Development Administration (NIDA) is accepting applications for admission to the Doctor of Philosophy (Ph.D.) Program in Business Administration (International Program) for the academic year 2017.

# 1.Qualification of Applicants

1.1 Applicants must hold a bachelor's degree with first class honor in any field or major from an accredited academic institution (Plan 2.2).

If the applicant has graduated from an institute outside of Thailand, he or she must obtain letter from the Bureau of Standards and Evaluation at the Commission on Higher Education, Ministry of Education in Thailand Tel: (66) 0 2354 5500-19 ext.725,727 or 728 indicating that their degree is recognized as sufficient.

1.2 Applicants must hold a master's degree in any field or major from an accredited academic institution (Plan 2.1).

If the applicant has graduated from an institute outside of Thailand, he or she must obtain letter from the Bureau of Standards and Evaluation at the Commission on Higher Education, Ministry of Education in Thailand Tel: (66) 0 2354 5500-19 ext.725,727 or 728 indicating that their degree is recognized as sufficient.

- 1.3 Applicants must conform to the requirements of NIDA's current announcement on English proficiency requirements for the International Program students as follows:
  - 1.3.1 Unless applicants are native English speakers or have obtained their bachelor's and/or master's degree (not more than five years ago) from international academic institutions in English-Speaking Countries, they are required to submit a test score from either the Test of English as a Foreign Language (TOEFL) or the International English Language Testing System (IELTS) exams. The minimum TOEFL score is 550 for the paper-and pencil test or 213 for the computer based test\*. For the

- IELTS, the minimum score is 6.5 points. (TOEFL or IELTS score taken for not more than 2 years)
- 1.3.2 Applicants who fail to meet the requirement in 1.3.1 but earn the minimum score required by NIDA, may be accepted into the program, provided that they conform to NIDA's rules on English proficiency.

**Remark:** \* internet based test score of not less than 79

Applicants can take the TOEFL/ITP (a type of TOEFL) exams (only TOEFL/ITP, arranged by NIDA or Institute of International Education is acceptable for application process), which NIDA also accepts. Applicants who want to take the TOEFL/ITP exam must contact the School of Language and Communication. ## 2. Selection Procedure

#### 2.1 Written Examination

Qualified applicants must take the NIDA Qualifying Examination which consists of:

- i) A Business Aptitude Test or have GMAT scores of at least 550(taken for not more than 2 years); which can be used as a substitute for the Business Aptitude Test.

**Remark**: The completed application form along with all required documents and original payment slip must be sent to NIDA within the due date. The applicant should keep a copy of all documents sent.

### 6. Condition for Full Scholarship

Recipients will be waived from tuition for the maximum period of three years and will be awarded monthly stipend of 10,000 baht under the following conditions:

- 6.1 Recipients of the scholarship shall maintain a minimum GPA of 3.30 in each semester. If the GPA fails to meet the criterion for any semester, the scholarship shall be immediately discontinued.
- 6.2 The recipient's leave of absence for any semester shall result in immediate cancellation of the scholarship. If resigning from the Institute or cancelling the scholarship, the recipient shall reimburse the awarded scholarship in full to the institute, unless the Committee considers otherwise.
- 6.3 In the event that scholarship recipients have to repeat any course, they shall not be exempt from the tuition fee for such re-enrolled class.
- 6.4 In the event that scholarship recipients wish to enroll in any course beyond their study plan, they shall be exempt from the tuition fee of such class upon recommendations in respect of the advisor only.
- 6.5 Scholarship recipients shall be exempt from the fee for the first-time comprehensive examination only. Consecutive comprehensive examinations shall not be exempt.
- 6.6 When the scholarship period ends, the student status retention fee shall be paid by scholarship recipients themselves.
- 6.7 Scholarship recipients shall work for the graduate school or the Institute at least 6 hours a week.
- 6.8 Copyrights in the dissertation shall be jointly owned by the student and the Institute for a period of five years.
- 6.9 The recipients has no rights to apply for any other scholarships of the Institute, except for the financial aids for research conduct and publication process allocated from the state budget.

- 6.10 Scholarship recipients themselves shall be responsible for the entire processing fee for dissertation revision.
- 6.11 The dissertation shall be published in the peer reviewed academic journals at international level.
- 6.12 The award period shall be 3 years. ( Counting from the first day when the scholarship recipient is registered as a student)
